

ENTRY ACCEPTANCE OF THESE TERMS AND CONDITIONS:

1. PROMOTER: The Promoter is RealNZ, 14 Captain Roberts Drive Te Anau

2. ELIGIBILITY: Open only those 18 years or over, who submit their photo via the TSS Earnslaw 110 Crowdriff Uploader. Employees of Promoter, its agencies or any entity involved in the development, production or administration of the promotion are not eligible to enter or win the prize. Void where prohibited by law.
